### สัญญาอนุญาตให้ใช้ข้อมูล

#### Creative Commons License

By exercising the Licensed Rights (defined below), You accept and agree to be bound by the terms and conditions of this Creative Commons License ("Public License"). To the extent this Public License may be interpreted as a contract, You are granted the Licensed Rights in consideration of Your acceptance of these terms and conditions, and the Licensor grants You such rights in consideration of benefits the Licensor receives from making the Licensed Material available under these terms and conditions.

#### Section 1 – Definitions.

**Adapted Material** means material subject to Copyright and Similar Rights that is derived from or based upon the Licensed Material and in which the Licensed Material is translated, altered, arranged, transformed, or otherwise modified in a manner requiring permission under the Copyright and Similar Rights held by the Licensor. For purposes of this Public License, where the Licensed Material is a musical work, performance, or sound recording, Adapted Material is always produced where the Licensed Material is synched in timed relation with a moving image.

**Adapter's License** means the license You apply to Your Copyright and Similar Rights in Your contributions to Adapted Material in accordance with the terms and conditions of this Public License.

**Sui Generis Database Rights** means rights other than copyright resulting from Directive 96/9/EC of the European Parliament and of the Council of 11 March 1996 on the legal protection of databases, as amended and/or succeeded, as well as other essentially equivalent rights anywhere in the world.

**You** means the individual or entity exercising the Licensed Rights under this Public License. Your has a corresponding meaning.

## Section 2 – Scope.

### 1. License grant.

1) Subject to the terms and conditions of this Public License, the Licensor hereby grants You a worldwide, royalty-free, non-sublicensable, non-exclusive, irrevocable license to exercise the Licensed Rights in the Licensed Material to:

#### 1.1. For Creative Commons Attribution License (G1) and Creative Commons Attribution-ShareAlike License (G3.1)

- reproduce and Share the Licensed Material, in whole or in part; and
- produce, reproduce, and Share Adapted Material.

#### 1.2. Creative Commons Attribution-NonCommercial License (G2) and Creative Commons Attribution-NonCommercial-ShareAlike License (G3.2)

- reproduce and Share the Licensed Material, in whole or in part, for NonCommercial purposes only; and
- produce, reproduce, and Share Adapted Material for NonCommercial purposes only..

#### 1.3. Creative Commons Attribution -NoDerivs (G4.1)

- reproduce and Share the Licensed Material, in whole or in part; and
- produce and reproduce, but not Share, Adapted Material.

#### 1.4. Creative Commons Attribution-NoDerivs-NonCommercial (G4.2)

- reproduce and Share the Licensed Material, in whole or in part, for NonCommercial purposes only; and
- produce and reproduce, but not Share, Adapted Material for NonCommercial purposes only.

2) **Exceptions and Limitations.** For the avoidance of doubt, where Exceptions and Limitations apply to Your use, this Public License does not apply, and You do not need to comply with its terms and conditions.

3) **Term.** The term of this Public License is specified in Section 6(a).

4) Media and formats; technical modifications allowed. The Licensor authorizes You to exercise the Licensed Rights in all media and formats whether now known or hereafter created, and to make technical modifications necessary to do so. The Licensor waives and/or agrees not to assert any right or

authority to forbid You from making technical modifications necessary to exercise the Licensed Rights, including technical modifications necessary to circumvent Effective Technological Measures. For purposes of this Public License, simply making modifications authorized by this Section 2(a)(4) never produces Adapted Material.

5) **Downstream recipients.**

**5.1. For Creative Commons Attribution License (G1) ,Creative Commons Attribution-NonCommercial License (G2) and Creative Commons Attribution-NoDerivs (G4.1) and Creative Commons Attribution-NoDerivs NonCommercial License (G4.2)**

**A. Offer from the Licensor** – Licensed Material. Every recipient of the Licensed Material automatically receives an offer from the Licensor to exercise the Licensed Rights under the terms and conditions of this Public License.

**5.2. For Creative Commons Attribution-ShareAlike (3.1) Creative Commons Attribution-NonCommercial-ShareAlike (3.2)**

**2. Other rights.**

3. The disclaimer of warranties and limitation of liability provided above shall be interpreted in a manner that, to the extent possible, most closely approximates an absolute disclaimer and waiver of all liability.

#### **Section 6 – Term and Termination.**

1. This Public License applies for the term of the Copyright and Similar Rights licensed here. However, if You fail to comply with this Public License, then Your rights under this Public License terminate automatically.

2. Where Your right to use the Licensed Material has terminated under Section 6(a), it reinstates:
- automatically as of the date the violation is cured, provided it is cured within 30 days of Your discovery of the violation; or
  - upon express reinstatement by the Licensor.

2. To the extent possible, if any provision of this Public License is deemed unenforceable, it shall be automatically reformed to the minimum extent necessary to make it enforceable. If the provision cannot be reformed, it shall be severed from this Public License without affecting the enforceability of the remaining terms and conditions.

3. No term or condition of this Public License will be waived and no failure to comply consented to unless expressly agreed to by the Licensor.

4. Nothing in this Public License constitutes or may be interpreted as a limitation upon, or waiver of, any privileges and immunities that apply to the Licensor or You, including from the legal processes of any jurisdiction or authority.
