Creative Commons License

 - 1.4. Creative Commons Attribution-NoDerivs-NonCommercial (G4.2)
- reproduce and Share the Licensed Material, in whole or in part, for NonCommercial purposes only; and
 - produce and reproduce, but not Share, Adapted Material for NonCommercial purposes only.
